



Q1 Switching Time Test Circuit


(a) Test Circuit





Q1 Usage Considerations

Let Vth be the voltage applied between gate and source that causes the drain current (ID) to below (1 mA for the Q1 of the SSM6L36TU). Then, for normal switching operation, $V_{GS(on)}$ must be higher than V_{th} , and $V_{GS(off)}$ must be lower than V_{th.} This relationship can be expressed as: V_{GS(off)} < V_{th} < V_{GS(on)}.

Take this into consideration when using the device.


Let V_{th} be the voltage applied between gate and source that causes the drain current (I_D) to below (-1 mA for the Q2 of the SSM6L36TU). Then, for normal switching operation, V_{GS(on)} must be higher than V_{th}, and V_{GS(off)} must be lower than V_{th.} This relationship can be expressed as: V_{GS(off)} < V_{th} < V_{GS(on)}.





















Q1 (N-ch MOSFET)















Q2 (P-ch MOSFET)















Q1, Q2 Common
